The mounting and splicing tape is able to withstand numerous environmental factors such as humidity, UV light, and temperatures of up to 200°C for limited periods of time. The tackified acrylic adhesive offers excellent hold on various surfaces, very high tack, and good shear strength. The adhesive is coated on a flexible and conformable cellulose nonwoven backing that even conforms to difficult 3D shapes.

tesa® 4959 is also available in a 160 μm version (tesa® 4962).
