

STATEMENT

tesa® 4965 (Original Next Gen), 6965 (Team 4965 Fingerlift), 51865 (Team 4965 Differential), 59650 (Team 4965 Thin 160µm), 4953 (Team 4965 Thin 100µm), 59651 (Team 4965 Thick), 49652 (Team 4965 High Transparency), 59652 (Team 4965 Black), 75505 (Team 4965 Transfer 50µm), 75507 (Team 4965 Transfer 75µm), 75515 (Team 4965 Transfer 125µm) – The corresponding product numbers are listed below.

The above mentioned tesa products has the same adhesive as tesa® 4965 PV8. tesa® 4965 PV8 was tested according to ISO 10993-10:2010 and ISO 10993-5:2009 in August 2019.

Based on the sample composition used in the tests, the products can be considered as safe for the use on intact human skin.

Results:

ISO 10993-10:2010: No skin sensitization reaction was found on the skin of white rabbits using extracts of the test results.

ISO 10993-5:2009: Under the condition of this study. the test article extract did not show potential toxicity to L929 cells.
